

## Karen Burt Memorial Award 2024

Launched on 3 November 1998, the Karen Burt Memorial Award is an annual award made by the Women's Engineering Society (WES) to the best Newly-Chartered Woman Engineer within that year in the following disciplines: engineering, applied science and IT.

The award recognises the candidate's excellence and potential in the practice of engineering and highlights the importance of Chartered status, as well as offering recognition to contributions made by the candidate to the promotion of the engineering profession. The winning candidate is awarded a prize of £1,000.

Dr Karen Burt was an eminent physicist who gained her PhD in electron microscopy at Reading University before joining British Aerospace as a project engineer for scientific satellites. She set up her own consultancy and was instrumental in establishing the Centre for Advanced Instrumentation Systems at University College London. Dr Burt is remembered as a gifted communicator and her fight to recover her speech and mobility following a stroke was an inspiration to all who knew her.

# **Making a Nomination**

Participating accrediting engineering institutions can **nominate one candidate annually,** following an internal institutional review process. Final selection is made by a WES panel based on further information provided by the candidate. This latter stage focuses particularly on the candidate's contribution to the engineering profession.

Professional Engineering Institutions are invited to select a candidate who has gained chartered status between March 2024-February 2025. Candidates can only be nominated once. See the *Karen Burt Memorial Award Terms of Reference below* for further details.

# KAREN BURT MEMORIAL AWARD 2024 TERMS OF REFERENCE

#### Aim

To commemorate the life of Dr Karen Burt, to encourage women to achieve chartered status and to promote the professions of engineering, applied science and Information Technology (IT). This award is presented annually to the best newly-chartered woman engineer who has demonstrated a commitment to the promotion of her profession. The chosen candidate must have been awarded chartered status between 1 March 2024 and 29 February 2025, and can only be nominated once.

#### **Background**

Dr Karen Burt was an eminent physicist who gained her PhD in electron microscopy at Reading University before joining British Aerospace as a project engineer for scientific satellites. She had an extensive and varied career before leaving to establish her own consultancy. After playing a leading role in establishing the Centre for Advanced Instrumentation Systems at University College London, her career was tragically cut short by an early death. Dr Burt influenced many people with her enthusiasm for engineering; she presented the Faraday Lecture and judged young designer competitions. She contributed to the work of the Women's Engineering Society, the Institution of Electrical Engineers, and the Institute of Physics, in particular offering advice to companies on the recruitment and retention of women. Dr Burt proved herself a role model to many by writing on career breaks and offering guidance based on extensive research and her own experience following the birth of her son. The range of her experiences and generosity made her an inspiration to all.

#### **Sponsor**

#### PROCEDURE FOR APPLICATIONS

#### Criteria:

- Each Institution may nominate one newly chartered woman engineer.
- The candidate must have achieved Chartership between 1 March 2024 and 29 February 2025.
- The candidate must be a UK resident. Candidates temporarily working outside of the UK will be deemed eligible only if their contract is under six months in duration, or if they are a serving member of the armed forces.
- Candidates can only be nominated once.



## Selection Criteria - optional for PEI use internally

The criteria listed below may be used by the Institution to select their best candidate. *There is no requirement to return this information to the Women's Engineering Society.* 

- Nominating Professional Engineering Institution
- Candidate's name
- Date Candidate was awarded Chartership
- Rating as practising Engineer
- Involvement with Institution affairs
- Involvement with activities to promote women in engineering
- Communication skills
- Enthusiasm for career
- Future plans and aspirations
- Any other outstanding qualities that may support the selection
